Complete	<p>July 2017 response: On December 10, 2011, amendments to the Health of Animals Regulations came into force to prevent the introduction of serious aquatic animal diseases into Canada, with the CFIA as the lead federal authority responsible for administration and enforcement of these regulations. At that time, the CFIA announced that susceptible species of finfish, molluscs, and crustaceans would require an import permit to enter Canada.
